RE: 2008 MORDEN CORN & APPLE FESTIVAL, AUGUST 22, 23, AND 24

The Morden Corn and Apple Festival is fast approaching and we would like to invite all artists and crafters to participate in our 42nd year of FREE FAMILY FUN on Friday, August 22nd, Saturday, August 23rd, and Sunday, August 24th.

Only PERSONALLY made items may be displayed and sold in the two large tents provided. Please use the enclosed application to apply to vend at this year's Festival. Fill out your application as completely and accurately as possible.

Set up on Friday, August 22, will be from 8:00 a.m. – 12:00 noon, and your items must be removed no later than 6:00 p.m. Sunday, August 24.

The tent will be open from 12:00 noon – 10:00 p.m. Friday, 11:00 a.m. – 10:00 p.m. Saturday, and from 12:00 p.m. – 5:00 p.m. on Sunday. The Morden Police service will have 24-hour auxiliary police patrolling the main street display areas.

There are also some street spaces available outside of the tent. These spaces are sold in 10-foot intervals. The fee covers one 10 by 12-foot space. Crafters in these spaces must provide their own tables and rain coverings.

All applications must be received by Friday, July 18, 2008. Please make your cheque or money order, for the full amount owing, payable to the Morden Corn and Apple Festival. Your processed cheque will act as verification of application acceptance. You will be notified closer to Festival date of your exact space location.

SPECIAL DISPLAY
TERMS AND CONDITIONS

1. There will be no subletting of booth space.
2. No weapons of any type are allowed at the Festival site nor can any weapon of any type be sold including knives.
3. No drug paraphernalia of any kind whatsoever shall be sold by a vendor which shall include any items that can be associated with illegal drug use including novelty pipes, nor shall any item display marijuana leaves.
4. Booths must be set up between 8 a.m. and 12 noon on Friday, August 22, 2008. Friday booth hours will be from 12:00 noon until 10:00 p.m., Saturday booth hours will be from 11:00 a.m. until 10:00 p.m. and Sunday booth hours will be from 12:00 noon until 5:00 p.m. Booth hours may be extended or start earlier on Friday and Saturday, but on Sunday booths are *not allowed* to be open earlier than 12:00 noon or later than 5:00 p.m. Booths must be removed by 6:00 p.m. on Sunday, August 24, 2008.
5. All vendors' booths must operate for the full 3-day Festival, being August 22, 23 and 24, 2008.
6. All booths must be completely free standing with no anchors of any type placed into the community street.
7. It is the responsibility of the vendor to maintain clean premises in and around the booth location.
8. The Corn & Apple Festival name and logo are registered and owned by the Corn & Apple Festival. No item may be sold by a vendor which displays the Corn & Apple Festival name or the Corn & Apple logo or a similar likeness unless purchased by the vendor from a Corn & Apple licensed wholesaler; all inquiries for the purchase of Corn & Apple Festival souvenir products are to be directed to the Corn & Apple Festival office and Morden Chamber Office at 204-822-5630.
9. Only *original, personally* made arts and crafts may be displayed in the craft tents, art tent and crafter's street space.
10. NO SMOKING in the Arts & Crafts Tents.
11. NO PETS. Do your pet a favour, leave them at home. There are a lot of people and it's hot!
